- Waterways (ditches/canals)
- Lakes (including interstate)
- Wetlands (many different types)



Why regulate waters of the U.S?






Percentage of Wetlands Acreage Lost, 1780's-1980's









The Clean Water Act

Purpose:

"to restore, protect and maintain the chemical, physical, and biological integrity of the nation's waters"

Section 404 of the Clean Water Act

permit required for discharges of dredged or fill material into waters of the U.S.

Section 10 of the Rivers and Harbors Act

permit required for work or structures in navigable waterways

- -Regional General Permit (No. 001)

- -Programmatic General Permits (Public Freshwater Lakes)

Illinois

- -Regional Permit Program (Effective April 1, 2012)
- -Nationwide Permits (ex.- NWP 5/Scientific Measurement Devices)

Permitting the Public: Examples of Section 10/404 Permits

- **❖Seawalls, Boat Ramps,**Shoreline Stabilization, Piers
- ❖Transportation projects including Tollway, INDOT, and Railroad Projects
- Utility Projects
- **❖Commercial, Residential,** Institutional Projects
- ❖Wetland & Stream Restoration Projects
- ❖Recreation Projects golf courses, trails, sports fields, parks and playgrounds
